1. Project Introduction

The Tobruk Power Station (TPS), located in eastern Libya, is one of the region's most important power generation facilities, with a total installed capacity of approximately 740 MW. The station comprises four gas turbine generators: two GE GT13E2 units and two Ansaldo AE94.2 units, all originally designed to operate on natural gas.

Due to the absence of a reliable natural gas supply infrastructure in the Tobruk region, the power station has historically operated on liquid fuel (Diesel), resulting in significantly higher operating costs, increased maintenance requirements, and reduced overall efficiency. To address this challenge, Delta FZ LLE has developed a project to restore the station's intended natural gas operation through the implementation of a dedicated LNG-to-power solution.

The project consists of the supply of natural gas to the Tobruk Power Station via an offshore Floating Storage and Regasification Unit (FSRU) located off the coast of Tobruk, adjacent to the power station. LNG delivered by carrier vessels will be received and regasified onboard the FSRU before being transported to the onshore facilities through floating hoses. Upon arrival onshore, the gas will pass through the Gas Compressor Station, where it will be compressed to the pressure required by the power station and distributed to the four gas turbines.

This solution has been selected as the most practical and expedient alternative to conventional pipeline infrastructure, offering reduced implementation time, a smaller environmental footprint, and enhanced flexibility while ensuring a reliable natural gas supply to the power station.

Delta FZ LLE is currently finalizing the engineering and procurement phases of the project and is initiating the pre-qualification and tendering process for the construction, installation, testing, commissioning, and start-up activities associated with the various project disciplines.

The selected contractors shall be responsible for the complete execution of the works within their respective scope of supply, including construction, installation, testing, commissioning, start-up support, and all associated services necessary to achieve a fully operational facility.

The ultimate objective of the project is to enable the Tobruk Power Station to operate on natural gas as originally designed, improving generation efficiency, reducing operating costs, enhancing reliability, and supporting the long-term energy requirements of eastern Libya.

2. Tender Announcement & Objective

4. Stage 1 – Pre-Qualification Requirements

Interested contractors are invited to submit their confirmation of interest and pre-qualification documents for evaluation.

As part of the pre-qualification stage, contractors shall clearly indicate the discipline or disciplines in which they wish to participate.

The confirmation of interest shall be submitted no later than 07 June 2026. The complete pre-qualification documents shall be submitted no later than 14 June 2026.

The pre-qualification submission shall include the following documents as a minimum:

Administrative and Legal Documents

- Company registration or incorporation certificate
- Tax registration certificate, such as VAT, TIN, or equivalent
- Business license or operating permit

5. Stage 2 – Tender Process

- Following completion of the pre-qualification evaluation, only qualified contractors will be invited to participate in the tender process.
- Delta FZ LLE will issue the official tender documents to qualified contractors on 15 June 2026, according to the discipline or disciplines approved during the pre-qualification stage.
- The tender documents will include the project requirements, instructions to bidders, technical scope, commercial requirements, contractual conditions, and submission requirements.
- A mandatory site visit to Tobruk Power Station shall be conducted during the tender period and before submission of the technical and commercial proposal.

The contractor shall submit a complete technical and commercial proposal no later than 05 July 2026, in accordance with the instructions included in the tender documents.

6. Stage 3 – Evaluation & Final Negotiation

Following submission of proposals, Delta FZ LLE will carry out technical and commercial evaluation.

Shortlisted bidders may be invited for clarification meetings and final negotiation. The negotiation may cover price, commercial terms, delivery time, execution schedule, contractual conditions, payment terms, resource availability, and any technical or commercial clarifications required before award.

The evaluation, clarification, negotiation, and decision-making process is expected to take place during mid-July 2026.

7. Stage 4 – Contract Award

After completion of evaluation and negotiations, Delta FZ LLE will notify the successful bidder or bidders selected for award per discipline.

Delta FZ LLE reserves the right to award the works as a complete package or split the award by discipline, depending on the best technical and commercial interest of the project.


